IN MARINE ENVIRONMENTS ARTICLE SHOULD BE WEEKLY WHASED WITH FRESH WATER. WE WOULD ADVISE USING GOLDEN CARE PRODUCTS AS THEY ARE SPECIALLY DESIGNED FOR CLEANING METAL, GLASS AND SYNTHETIC FIBRES.
