

LOUNGE CHAIR WITH LEGS IN IROKO WOOD/ALUMINIUM, SEAT IN FABRIC AND BACKREST VAR#ROPE. SEAT: QUICK DRY POLYURETHANE PADDING IN SEVERAL DENSITIES + RESIN POLYESTER FIBER COMBINED WITH POLYESTER MESH. REMOVABLE CUSHION COVER. BACK CUSHION: 100% SPIRAL SILICON POLYESTER FIBER PADDING WITH OUTSIDE MESH IN POLYPROPYLENE. REMOVABLE CUSHION COVER. CHARACTERISTICS OF THE COVERS ARE DESCRIBED IN THE VARASCHIN FOLDER "FABRICS".

FOR DAILY CLEANING USE A DRY COTTON CLOTH. FOR MORE THOROUGH CLEANING USE ONLY A NEUTRAL PRODUCT DILUTED IN WARM WATER. NEVER USE ALCOHOL, AMMONIUM, THINNERS OR ABRASIVE PRODUCTS. IN MARINE ENVIRONMENTS ARTICLE SHOULD BE WEEKLY WHASED WITH FRESH WATER. WE WOULD ADVISE USING GOLDEN CARE PRODUCTS AS THEY ARE SPECIALLY DESIGNED FOR CLEANING METAL, GLASS AND SYNTHETIC FIBRES.
