SEAT: QUICK DRY POLYURETHANE PADDING IN SEVERAL DENSITIES + RESIN POLYESTER FIBER COMBINED WITH POLYESTER MESH. REMOVABLE CUSHION COVER.

BACK CUSHIONS: 100% SPIRAL SILICON POLYESTER FIBER PADDING WITH OUTSIDE MESH IN POLYPROPYLENE. REMOVABLE CUSHION COVER.
