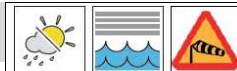

ANODIZED ALUMINIUM FRAME COMPLETE WITH POLYESTER CURTAINS. ROUND GRAVEL BASE. PULLEY OPENING SYSTEM. COVER: ECRU/WHITE POLYESTERS.

PRECAUTIONS

THE UMBRELLAS AND RESPECTIVE COMPONENTS OF THE BASES MUST BE ASSEMBLED CORRECTLY, IN RESPECT OF THE ASSEMBLY INSTRUCTIONS. THE STATIC CALCULATIONS RELATING TO THE WIND, COUNTERWEIGHT BASES HAVE BEEN MADE CONSIDERING PERFECTLY FLAT EVEN FLOORS OR GROUND. THEY ARE NO LONGER VALID IF THE FLOORS OR GOUND ARE EVEN SLIGHTLY INCLINED OR UNEVEN. THIS COULD MAKE THE UMBRELLA DANGEROUS. IT IS IMPORTANT TO BE AWARE THAT THE UMBRELLA IS NOT FIXED TO THE FLOOR AND THEREFORE SHOULD BE OPENED ONLY AND USED IN STABLE METEROLOGIC CONDITIONS. IN CASE OF HIGH WINDS, SNOW OR UNSUITABLE WEATHER CONDITIONS THIS SHOULD BE CLOSED IMMEDIATELY AND BLOCKED WITH THE APPROPRIATE RIBBON. IMPROPER USE OF THE UMBRELLA IS NOT ALLOWED.

VARASCHIN IS NOT LIABLE FOR DAMAGE CAUSED BY IMPROPER USE. IT IS ESSENTIAL TO BEAR IN MIND THAT THE SUNSHADE IS NOT A STRUCTURE FIXED TO THE GROUND AND IS THEREFORE TO BE KEPT OPEN ONLY WHEN IN USE AND GUARDED. IN THE EVENT OF STRONG WINDS, SNOW OR UNSUITABLE WEATHER CONDITIONS, KEEP CLOSED. IF THE GAZEBO IS NOT FIXED TO THE GROUND (IT IS DESIGNED FOR FIXING) IT CANNOT BE SAID WHAT TYPE OF WEATHER CONDITIONS WILL COMPROMISE ITS STABILITY.

GENERAL INSTRUCTIONS FOR MAINTENANCE AND CLEANING

FOR DAILY CLEANING USE A DRY COTTON CLOTH. FOR MORE THOROUGH CLEANING USE ONLY A NEUTRAL PRODUCT DILUTED IN WARM WATER. NEVER USE ALCOHOL, AMMONIUM, THINNERS OR ABRASIVE PRODUCTS. IN MARINE ENVIRONMENTS ARTICLE SHOULD BE WEEKLY WHASED WITH FRESH WATER. WE WOULD ADVISE USING GOLDEN CARE PRODUCTS AS THEY ARE SPECIALLY DESIGNED FOR CLEANING METAL, GLASS AND SYNTHETIC FIBRES. FOR CLEANING AND TAKING CARE OF FABRICS, SEE THE VARASCHIN SPA "FABRICS" FOLDER.
